Ms. Karrie Kuklish, Communication Specialist, presented information and shared two short videos highlighting Career and Technical Education opportunities and Grand River Academy. 2. Strategic Plan Focus Group #2 Update Ms. Nikki Jost, Human Resource Executive Director, Dr. Danny Medved, Professional Learning Director, and Mrs. Connie Mack, Benefits Manager, shared information on the three priority areas under the Strategic Plan Focus Group of Prepared and Supported Staff. The three priority areas are Professional Learning, Diverse & Growing Pipelines and Staff Wellness. Ms. Jost, shared information on Diverse & Growing Pipelines priority area to grow a diverse and healthy pipeline of qualified leaders and educators. She reported her team is progressing and responding to new challenges, with the possibility of school consolidations. She shared information on steps displaced staff will need to take if consolidating schools. She reported all job postings are on hold until final decisions are made regarding school consolidations. She reported, Mr. Carter Ness, Certified Recruiting Specialist, has attended job fairs and serving on a Colorado Department of Education Job Board Committee to strengthen recruiting efforts. Mrs. Connie Mack, Benefits Manager, spoke on the priority area of Staff Wellness. She shared data on staff wellness, trends, and uncertainties based on staff responses on this year's Panorama Survey and job exit interviews and on Triad staff participation. Triad offers resources to assist staff members with depression, anxiety, grief, and many other things effecting a person's overall wellness. She reported on the work being done to strengthen staff wellness including items added to help staff deal with anticipated school closures. She reported on current activities and next steps to improve overall staff wellness. Dr. Medved explained a grant funded program the District is using, Pathway to Principalship, to advance District staff who show good leadership skills. Dr. Medved was joined by Ms. Heather Flick and Ms. Jamie Burnham, Instructional Coaches Coordinators, Ms. Britny Walker, Curriculum and Learning Design Specialist, and Ms. Linnea Hulshof, Cultural, Linguistically and Diverse Education Coordinator, to report on the priority area of Professional Learning. Dr. Medved reported his team is prepared to shift and adjust in-service trainings should school consolidations happen. He described the defined autonomy approach to equip leadership teams rather than site based management. Ms. Walker shared information on data-informed learning communities to shift focus from teaching to learning and to move from working in isolation to working collaboratively. She explained the work being done in Learning Communities to identify learning gaps and to improve social emotional learning at the middle and high school levels.

A vote was taken to Aye Χ Χ Χ Х amend the motion, with Mr. Levinson abstaining as he did not understand the No motion to amend Ms. Lema's initial motion. Abstain Х Mrs. Haitz read a statement, approved by legal counsel, regarding a lawsuit filed against Marillac and Monument Health. The lawsuit alleges misappropriation of grant money at the school based health center at Central High School, the Warrior Wellness Center. The lawsuit, filed in 2022, was brought to the District's attention by an anonymous person via a feedback page on the District's website. Board members shared their thoughts regarding a school based health center at **Grand Junction High School:** Mrs. Haitz reported on trying to work with Marillac, to find a compromise by having the center located outside the main school building but in near proximity of the school. She noted Marillac reported that would not work for Mr. Jones expressed concern over the lawsuit and the lack of transparency with Marillac failing to notify the District. He was uncomfortable in approving the school based health center while a lawsuit was pending. He preferred the center be located outside of the main school building. Ms. Lema reported she feels the District needs to concentrate on education and not be involved in selecting health care professionals for students. She would have been more comfortable in having the center outside of the main building. Mr. Levinson expressed his belief, if focusing on what is best for students. one would have to vote in favor of the center. He spoke on the center aligning with the Strategic Plan and how school buildings are used, on a regular basis

						students. Mr. Levinson reported on a resolution, previously adopted by the Board in 2019, showing support for school based health centers, prior to the Warrior Wellness Center opening. He questioned if rejection of this resolution would result in the closing of the Warrior Wellness Center at Central High School. Mrs. Haitz clarified the resolution only address a school based health center at Grand Junction High School. • Dr. Sholtes spoke on a lack of evidence or data to show improved student education outcomes at schools with a school based health center, but noted there is a data showing a thirty percent reduction in student suicide rates and depression at schools with school based health center, which should equate to better student outcomes. She noted in allowing a school based health center at Central High School and not Grand Junction High School feels political. She believes a school based health center needs to be within the schools for student safety, and the new Grand Junction High School was designed for students to stay safe within one main building.

WHEREAS, on August 10, 2020, the Warrior Wellness Center, a school based health center, operated by Marillac Health, was opened at Central High School; and

WHEREAS, with the construction of a new Grand Junction High School space will be available for a SBHC; and

WHEREAS, Marillac Health is interested in establishing an SBHC at Grand Junction High School; and

WHEREAS, the Board of Education heard information regarding SBHCs and the 2018 Needs Assessment at a January 11, 2023, Special Board Meeting; and

WHEREAS, the general public has had opportunity to submit comments and concerns to the Board of Education and/or give verbal feedback at the January 17, 2023 Board Business Meeting and the February 21, 2023 Board Business Meeting; now

THEREFORE, BE IT RESOLVED, the Board of Education hereby wishes to proceed with establishing a SBHC at within Grand Junction High School; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Mesa County Valley School District 51 Board of Education hereby directs the District's legal counsel to work with Marillac Health in preparing a Memo of Understanding to establish and operate a SBHC at Grand Junction High School.
