The suggested boundary changes would shift 2023-2024 sixth grade students living Appleton Elementary School boundary area, west of 25 Road, from Fruita Middle School to Redlands Middle School. Mr. Bingham shared the majority of parents, in attendance, were in favor of shifting from the Fruita Middle School to Redlands Middle School. He reported some parents requested extending the proposed boundaries shifts to include a larger area to the west. Mr. Bingham will work on gathering data for three possible scenarios, hold an additional parent meeting with parents of students affected by the various scenarios and report stakeholder feedback back to the Board.
