						 Presentation of Survey Results: Mr. Floyd Ciruli Mr. Ciruli reported the findings of the telephone survey administered by Ciruli Associates. The survey was given to a random sample of 500, active Mesa County registered voters, and was given July 24-29, 2008. Comparisons were made to a previous survey taken February 18-24, 2008, with a sample of 600 voters. Mr. Ciruli reviewed the survey results and gave general comments. Board members asked questions and engaged in discussion as the information was presented. The survey results included questions in the following areas: Bond Issue for Facilities; Operation-Maintenance; Direction; Economy; Government Rating; School Grades; Long-Range Planning Committee; Specific Projects & Costs; Opinion Statements; Policy Choice Questions; High School Question; Efficient Buildings; Final Ballot Question for Bond; Demographics. Melissa Callahan DeVita, Executive Director of Support Services, and Shannon Bingham, District Demographer, presented a PowerPoint presentation which addressed open items from previous board discussions. Those areas focused on the following questions: What industries are contributing to growth in the valley? What projects are included for current schools? Can we incorporate the capital needs of full-day kindergarten? Where should the second elementary school go? What do we expect enrollment to be at the high schools if two new high schools open?
