						<p>E. BOARD REPORTS/COMMUNICATIONS/REQUESTS: None at this time.</p> <p>F. LEGISLATIVE REPORT: None at this time.</p> <p>G. AUDIENCE COMMENTS: None at this time</p> <p>H. SUPERINTENDENT'S REPORT</p> <p>H-1. Extended Learning: Cathy Haller, Steve States & Lee Carlton</p> <ul style="list-style-type: none"> > A PowerPoint presentation was given by the leadership team to report on the status of the Extended Learning Board Goal: <i>To develop and implement extended learning time for increased interventions to support the improvement of student performance.</i> The areas presented included the following: <ul style="list-style-type: none"> • The mission statement, "to provide a seamless educational program for all students in the "red zone," as well as providing enrichment activities for all students. It is our desire to ensure that all students receive responsive instruction that meets their educational needs." • Quotes from several students, parents and teachers, regarding this opportunity as a positive experience for students to learn. • Data charts and information were provided in the following areas: enrollment, attendance rate, student breakdown by levels, free & reduced summary percentages, high school course completion data, curriculum-based assessments used for pre and post testing to report average growth, sample forms for tracking progress, budget, successes and next steps. • Key-points of the presentation included: enrollment is up at 2,034 in 2007 compared to last year at 809; the schools were instrumental in identifying children needing extra help – growth data is given back to the school to assist in moving the student forward; continued work will go into streamlining the process and identifying consistent data to collect; a single 9-week session will be considered; and a budget will need to be developed to support expected enrollment increases next year. > Mr. Robinson emphasized the importance of establishing and meeting clear, quantifiable goals to demonstrate accountability and to ensure positive results, before increased funding is provided to the program. He would like to see goals specific to gender, ethnicity, and free & reduced lunch students. Mr. Robinson is concerned about new information coming out about boys not being motivated to pursue educational endeavors; he mentioned a book entitled <i>Boys Adrift</i>, which delves into this issue. > Mr. Butler proposed the possibility of talking to retailers around the valley to participate. > Mr. Robinson suggested changing the name of the extended learning summer program to an "academy," for a specialized group of students and teachers. He also suggested the possibility of paying students as an incentive to do well in the program. > Board members asked questions about the data, transportation, and food service. Additional information will be provided regarding ethnic, gender, free & reduced lunch students, and the number of "red-zone" students served. > Dr. Mills summarized the areas previously mentioned for specific goals, and concluded by stating the purpose of the extended learning program is to provide an opportunity for students to have additional time to learn; it is skill focused, limiting the regression of learning that happens over the summer.

						<p>H-2. 2006-2007 End-of-Year Business/Investment Reports</p> <ul style="list-style-type: none"> > Dr. Mills presented the routine, end-of-year financials, gave an overview of funds and asked the Board if they had questions or comments. > Mr. Robinson pointed out how the general fund balance has increased over previous years, and commended the classified and certified staff, the teacher association, and the executive directors for their part in being conscientious regarding district funds. He credited the leadership and work of Dr. Mills in improving the fund balance to current levels, with a 2006-2007 balance of over six million. He stated that District 51 is not a rich district; the district's fund balance has improved from a district that was in the "hole" six years ago to one which would be considered a "AAA" rated company. > Dr. Mills spoke of the establishment of budget parameters as a factor in maintaining the fund balance. He stated that a lot of work has been done to stabilize and maintain the fund balance to provide direct resources to students. District 51 provides 74% of its budget for instruction and pupil support, which is one of the highest percentages in the state. > Mr. Rowley commented on energy costs; he favors striving for and setting a higher standard for energy efficiency to reduce costs. <p>H-3. 2007-2008 Business/Investment Reports</p> <ul style="list-style-type: none"> > No further comment was made, regarding the beginning 2007-2008 school year routine reports. <p>I. 						<p>INTRODUCTIONS: Dr. Mills introduced the following administrators in attendance who are new to their positions this year:</p> <ul style="list-style-type: none"> > Anna Goetz, Palisade High School, Assistant Principal > Mike Allison, Redlands Middle School, Assistant Principal > Pat Chapin, Orchard Mesa Middle School, Assistant Principal > Curry Newton, Rimrock Elementary School, Administrative Intern <p>L. BOARD OPEN DISCUSSION:</p> <ul style="list-style-type: none"> > Mr. Gebhard opened discussion, regarding teacher evaluation. He emphasized the need for accountability to reach teachers, students, and parents, to raise proficiency. > Mr. Robinson appreciates Mr. Gebhard keeping this subject on the table. Mr. Robinson conveyed his belief that the Board and the District will never be satisfied with test scores. > Further discussion included: the connection between teacher performance and the assessment results of students, the role and responsibility of middle school and high school progress monitors, the importance of student achievement and the role of the classroom teacher, the competitive factors in our modern society taking students away from academic endeavors, parent involvement, Christian values, and current beliefs around the importance of a college degree. > Mr. Rowley reminded Board Members of the work done with the Baldrige Model and the consultant, Judy Phillips, to bring accountability to the student level. > Dr. Mills spoke about what is being done at the state level and the work of the new Commissioner of Education. Doing away with assessment or accountability is not being discussed; however, work is being done to re-evaluate the standards which have been in place for 13 years to see if they are still relevant, and exploring ways to get information back to individual students in a timely manner to assist them in improvement efforts. > Further discussion regarding teacher evaluation and student performance will be held when Mrs. Kiesler is back, at the Board's Regular Meeting on October 2. <p>M. FUTURE MEETINGS: Reviewed</p> <ul style="list-style-type: none"> > Mr. Rowley reminded Board Members of several upcoming events: a celebration of the new synthetic turf at Stocker Stadium at noon on September 25, the band festival on October 6, and plans for groundbreaking of the new downtown elementary school (date/time to be determined). > Mr. Robinson requested a report from the District's Attendance Officer to review current data. Recognition: Kathy Joseph, 2007 Colorado Band Masters Association Hall of Fame

Kathy Joseph, Music Coordinator for School District 51, was inducted into the Colorado Bandmasters Association Hall of Fame during the Annual Colorado Bandmasters Association Award Banquet July 19-20, 2007. Ms. Joseph is the first woman and only the second inductee from the western slope of Colorado since the Hall of Fame's inception in 1976.

Ms. Joseph graduated from Northern Michigan University in 1976 with a Bachelor of Music Education and received her Masters of Music Education in 1981. She began teaching in Hotchkiss, Colorado in 1982, after teaching five years in Michigan. During her seven-and-a-half years in Hotchkiss, her bands earned numerous awards including two state marching championships and were named several times as the Outstanding Concert and Jazz Band at the Colorado West Music Festival. The 100+ member Hotchkiss band was also selected to perform at the state CMEA Convention in Colorado Springs.

In 1989 Ms. Joseph began teaching at Grand Junction High School. During the next seven years, her bands continued their stride for excellence earning top honors as the Colorado West Outstanding Jazz Combo, Outstanding Jazz Band, Outstanding Concert Band, Outstanding Marching Band, and they received the Colorado West Sweepstakes Award six times.

When Ms. Joseph transferred to Mt. Garfield Middle School in 1996, she established a jazz program that became the model for the other middle schools in District 51. Her middle school concert and jazz bands continued earning superior awards during the next eight years. Over the course of her Colorado career Kathy's bands received CBA Exemplary Band Awards and superior ratings for over 20 years. She retired from the classroom in 2004 and is currently serving Mesa County School District 51 as their Music Coordinator.

In addition to her teaching duties, Kathy has served throughout Colorado as a clinician, conductor, and adjudicator for concert, solo and ensemble, and marching bands in both Colorado and New Mexico. She has provided clinics in sight reading for CMEA and has spoken on several panels for the CBA conventions. Kathy has also served several band and booster programs throughout the state as a leadership trainer and motivational speaker. In 1997 she founded the Western Colorado Marching Effects Camp and has served as the camp coordinator and drum major instructor until 2006.

Ms. Joseph first served on the State CBA board in 1984 as the Western Slope Representative. Later she served as the recording secretary and spent three years as the executive secretary. After a year as president-elect, Kathy served the first two-year term as president of the state CBA and finally a two year term as past president before retiring from the board. Kathy made several contributions to the Colorado Band Association and to the state of Colorado during her 10 years of service on the state board. She proposed that CBA award state champion marching band medals, was involved in the initial promotion of the Exemplary Band Award as well as the State Concert Band Festival, and was the spear-head for the state handbook. Ms. Joseph has taken real pleasure in being able to serve others during her career.

It is with great honor we recognize this achievement, and honor an individual who has supported music education in School District 51 for many years. Ms. Joseph has truly made a positive impact in the lives of her students and the lives of many colleagues.



Each year in Colorado, the Colorado Bandmasters Association (CBA) presents awards to bands that demonstrate excellence in their craft. Middle and high school bands are eligible for the Exemplary Band Award if the director of the band is a member of the CBA, and if the band has met predetermined criteria within a single school year. These bands must demonstrate superior performances in concert band as well as in 2 out of 4 of the following areas: marching, solo ensemble, jazz band, and total band student enrollment. We are proud to have four middle schools and one high school whose bands have qualified for, and received this prestigious award out of nine awards given in Colorado.

We are proud to recognize Paul Traugott from Central High School, Brett Argo from East Middle School, Debbie Wilson from Grand Mesa Middle School, Sarah Kamstra from Redlands Middle School, and Joe Webb from Fruita Middle School, and their bands for receiving the 2006-2007 Colorado Band Masters Exemplary Band Award.

At the high school level, Paul from Central received the CBA Exemplary Band Award, in part, due to the band's 9th place finish at the State Marching Band Championships, for qualifying for the State Concert Band Festival in April, a very high percentage of entries in solo and ensemble festival, and receiving superior ratings for all the bands at Central High School. Only five high schools in the state received this coveted award. The bands at Central were very honored to receive such an award and will continue to strive for greater accomplishments in the years to come.

The East Middle School Band program received the CBA Exemplary Band Award due to the 6th and 7th grade bands receiving Superior ratings at large group festival, the 8th grade Jazz Ensemble receiving a Superior rating at large group festival, and from the large percentage of participants in band. The band program at East had a very high participation rate last year with more than 50% of the total student body. In addition to this, a large number of students received Superior ratings at Solo/Ensemble Festival, 8 students were selected for the CBA Middle School Honor Band, and 3 were selected for the WSCBA Honor Jazz Band.

Grand Mesa Middle School received the CBA Exemplary Band Award for reaching a total of 100 points through outstanding work in various aspects of the band program during the 2006 – 2007 school year. These points were accumulated through Superior ratings at large group festivals, a large number of Superior ratings at Solo/Ensemble Festival, a high percentage of students enrolled in the

band program, and students of the Grand Mesa Band program being accepted into an honor band through their audition.

The Redlands Middle School Band program had outstanding success in student participation, large and small ensembles, and individual performance during the 2006-2007 school year. Over 200 students (about 32% of the student body) in Grades 6 through 8 participated in the band program. Both the 7th Grade Concert Band (66 members) and 8th Grade Concert Band (57 members) received straight Superior ratings at the Colorado West Music Festival. 40 of their 47 entries at Solo/Ensemble Festival earned Superior ratings, all others received Excellent ratings. Eight students were selected for CBA Middle School Honor Concert Band - of those, all placed 1st, 2nd or 3rd chair by audition, and 3 students successfully auditioned into the CBA Middle School Honor Jazz Band.

At Fruita Middle School Band both 6th and 7th Grade Concert Bands received Superior Ratings at the Colorado West Music Festival, 20% of the Band Students received a Superior Rating at Solo/Ensemble Festival, 22% of all students at FMS are enrolled in Band during the 2006-07 school year, the FMS Jazz Band received an Excellent Rating at the Colorado West Music Festival, and two 7th grade students were selected to the CBA Western Slope Honor Jazz Band.

All of these bands are truly models of excellence, as are their directors! Congratulations to each of you and to all of your young musicians.

Students Studying Abroad Amendment to Board Policy IKF

Board of Education Resolution 07/08-13

1st Reading & Information: September 18, 2007

WHEREAS, Mesa County Valley School District 51 encourages exposure of students to different cultures, and encourages opportunities for students to develop proficiency in a foreign language; and

WHEREAS, student exchange between countries is a pathway to accomplish these objectives.

THEREFORE, BE IT RESOLVED, each high school and middle school will make students aware of this district policy, and encourage student participation in out-of-the country exchange programs; and

1. Students will receive 2 semesters foreign language credit for every semester spent studying at a school where English is not the dominant language.
2. Students will receive 1 semester elective credit in humanities for their out-of-the-country living experience.
3. Credit in any other content areas will be awarded upon submission by the student evidence of proficiency or appropriate student work in that content area.
4. The safety and the quality of the student exchange program will solely be determined by the student and his or her parents or guardians. The district will not be responsible for determination of safety, quality or appropriateness of any exchange program.
