Chipeta Elementary School Project Update: Cal Clark &amp; Ethan Gibson</p> <ul style="list-style-type: none"> <li>➤ Several PowerPoint slides were shown as the presentation was given.</li> <li>➤ Cal Clark highlighted many of the construction and site features that provide energy efficiency and sustainability. Some of those features mentioned include: prime parking for hybrid vehicles and bicycles, showers for school staff, white roofing, low-flow water fixtures, sustainable wood products, multi-level lighting, and large windows in classrooms. The LEED status has not changed, remaining at Silver.</li> <li>➤ Mr. Rowley asked about an estimate for energy use. Ethan Gibson will provide that information.</li> <li>➤ The project is on schedule and within budget, and is considered to be a "fast track project," taking 15 months from design to building.</li> </ul> <p>H-2. Master Plan: Mr. Keith Boyd, AMD</p> <ul style="list-style-type: none"> <li>➤ Mr. Boyd provided a PowerPoint presentation to review what has been done in the past, where we are today, the effects of smaller schools, demographics, growth, and how to best allocate use of a possible bond package. He reviewed the purpose of the master plan, the plan's components, District plan integration; summary of work from the 2004 bond, facility assessments which includes safety, repair/maintenance program deficiencies, technology, cost, priority, and risk management; educational specifications, academic models, school size; and educational mission and delivery.</li> <li>➤ Board members discussed the type of projects that would be included, and asked when the final Master Plan would be published.</li> <li>➤ Dr. Mills indicated the updated Master Plan will be provided within the next few months. WHEREAS, on April 22, 2008, representatives of the Grand Valley Lacrosse Club (GVLC) presented to the Mesa County Valley School District 51 Board of Education a request to add lacrosse as an interscholastic sport offered in the District's high schools; and

WHEREAS, there is sufficient student interest in the District to support establishment of lacrosse teams for both boys and girls at the high school level; and

WHEREAS, the Board of Education desires to promote a diversity of opportunities for District students to participate in athletics, and to that end favors allowing District students to participate in lacrosse as sanctioned by the Colorado High School Activities Association (CHSAA), but does not desire the District to assume new financial or management burdens in connection with its interscholastic athletic programs that exceed available resources; and

WHEREAS, GVLC has committed to provide financial and administrative support for a District lacrosse program with the goal of elevating the status of lacrosse from that of a "club sport" to that of a District-sponsored high school sport with a CHSAA-sanctioned competitive schedule.

WHEREAS, the Board is aware that at least one other Colorado school district has provisionally added lacrosse to its interscholastic high school athletic program pursuant to special cooperative arrangements with private club or parent organizations that provide funding and other management support, and desires to pursue a similar arrangement with the GVLC.

THEREFORE, BE IT RESOLVED, the Board of Education approves the addition of boys and girls lacrosse to the District's interscholastic athletic program as a "provisional status" sport offered to students in the District's high schools beginning in the spring of 2009. Such approval does not include or authorize expenditure of District funds or application of other District resources for day-to-day administration of lacrosse activities in the schools, and is conditioned upon and subject to execution of a memorandum of understanding between the District and the GVLC, in form and content acceptable to both parties, setting forth the functions and responsibilities of the parties regarding the establishment, operation and funding of the contemplated lacrosse program, including, but not limited to, the terms of GVLC's financial commitment, the selection and employment of coaches, engagement and training of officials, and support for participation by students with limited financial resources.

BE IT FURTHER RESOLVED, that the Superintendent of Schools is authorized to prepare and implement a suitable memorandum of understanding with GVLC in conformity with the foregoing conditional approval. The Superintendent is further directed to notify CHSAA of the matters set forth in this resolution, and to take such other and further action as may be necessary or appropriate to establish a CHSAA-sanctioned provisional lacrosse program subject to the terms and conditions expressed herein.

### **USE OF PHYSICAL INTERVENTION**

---

District staff members shall not administer corporal punishment to students at any District school. In dealing with disruptive students, any person employed by the district may, within the scope of his/her employment, use reasonable and appropriate physical intervention or force as necessary for the following purposes:

1. To prevent a student from an act of wrong-doing.
2. To quell a disturbance threatening physical injury to others.
3. To obtain possession of weapons or other dangerous objects upon a student or within the control of a student.
4. For the purpose of self-defense.
5. For the protection of persons or property.
6. To maintain or restore order and discipline.

Any such acts are not in conflict with the legal definition of child abuse and shall not be construed to constitute corporal punishment within the meaning and intent of this policy.

However, any method or device used by District employees to involuntarily limit a student's freedom of movement, including physical force, mechanical restraint, physical restraint, chemical restraint or seclusion, shall be in compliance with state law and regulations regarding protection of persons from restraint. The superintendent shall develop procedures and a training program related to the use of restraint that is consistent with this policy and applicable laws and regulations.

#### *Change of Statute CRS 22-33-104, 22-33-107(3): Effective July 1, 2008*

---

Every child who has attained the age of ~~seven (7)~~ **six (6)** years **on or before August 1 of each year** and is under the age of seventeen (17) is required to attend public school during each school year for at least one thousand fifty-six (1,056) hours if a secondary school pupil, nine hundred sixty-eight (968) hours if an elementary school pupil in a grade other than kindergarten, nine hundred (900) hours if a full-day kindergarten pupil and four hundred fifty (450) hours if a half-day kindergarten pupil, with such exceptions as provided by law. Exceptions include a child:

1. who is temporarily ill or injured or whose absence is approved by the building principal;
2. who is enrolled for a minimum of one hundred seventy-two days in a independent or parochial school which provides a sequential program of instruction which includes, but is not limited to, communication skills of reading, writing, and speaking, mathematics, history, civics, literature and science;
3. who is absent for an extended period due to physical, mental or emotional disability;
4. who has been suspended, expelled or denied admission in accordance with the provisions of ~~this article~~ **state law and board policy**;
5. to whom a current age and school certificate or work permit has been issued pursuant to the "Colorado Youth Employment Opportunity Act of 1971", article 12 of title 8, C.R.S.;
6. who is in the custody of a court or law enforcement authorities;
7. who is pursuing a work-study program under the supervision of a public school;
8. who has graduated from the twelfth grade;
9. who is being instructed at home:
  - a. by a teacher certified; or
  - b. under a non-public home-based educational program pursuant to § 22-33-104.5, C.R.S.; or
10. who is enrolled in a school where the state board of education has approved a lesser number of days.

Parental Responsibility. Colorado law (§ 22-33-104(5)(a), C.R.S.) declares that two of the most important factors in ensuring a child's educational development are parental involvement and parental responsibility. The law further declares that it is the obligation of every parent, except parents whose children are enrolled in an independent or parochial school or a nonpublic home-based educational program, to ensure that every child under such parent's care and supervision receives adequate education and training and, therefore, that every parent of a child who has attained the age of ~~seven (7) years~~ **six (6) years on or before August 1 of each year** and is under the age of seventeen (17) years shall ensure that such child attends the public school in which such child is enrolled in compliance with the requirements of the law.

Enforcement of Compulsory School Attendance. The Board shall designate one or more of the employees of the district to act as attendance officer for the district. It is the attendance officer's duty in appropriate cases to counsel with students and parents and investigate the causes of nonattendance and report to the Board so as to enforce the provisions of the School Attendance Law of 1963. The maximum number of unexcused absence that a student may incur during any calendar year before judicial proceedings may be initiated is 7 days, or an accumulation thereof.

***Change of Statute CRS 22-33-104, 22-33-107(3): Effective July 1, 2008***

---

With respect to a child who is “habitually truant” (meaning a child who has attained the age of ~~seven (7)~~ six (6) years **on or before August 1 of the year in question** and is under the age of seventeen (17) years having four unexcused absences from public school in any one month or ten unexcused absences from public school during any school year – absences due to suspension or expulsion of a child to be considered “excused” absences for the purposes of truancy enforcement under this section) the school shall:

1. Develop a plan for a student who is declared habitually truant with the goal of assisting the child to remain in school. When practicable, the child’s parent, guardian or legal custodian shall participate with district personnel during the development of the plan. Appropriate school personnel shall make all reasonable efforts to meet with the parent, guardian or legal custodian to review and evaluate the reasons for the child’s truancy;
2. Annually at the beginning of the school year and upon any enrollment during the school year, notify the parent of each child enrolled in a school of the district in writing of such parent’s obligations pursuant to section 22-33-104(5), C.R.S.;
3. Annually at the beginning of the school year and upon any enrollment during the school year, obtain from the parent of each child a telephone number or other means of contacting such parent during the school day; and
4. Establish a system of monitoring individual unexcused absences of children which shall provide that, whenever a child fails to report to school on a regularly scheduled school day and school personnel have received no indication that the child’s parent is aware of the child’s absence, school personnel or volunteers under the direction of school personnel shall make a reasonable effort to notify by telephone such parent.

**Whereas:** Negotiations between Mesa County Valley School District No. 51 (District) and the Mesa Valley Education Association (MVEA) occurred on April 18 and 19 and May 2 and 3, 2008; and

**Whereas:** The items agreed to include:

#### Salary & Insurance

All cells in the salary schedule will be increased by 3.5%. If the October 2008 enrollment is at least 150 FTE greater than the previous October count, an additional .75% will be added to the salary schedule starting January 2009. An additional lane for MA+48 will be added to the salary schedule between the MA+36 and the Doctorate steps.

If expenditures are less than budgeted during the 2008-2009 school year, then each full time teacher will receive a one-time stipend in June based on a ratio of \$235 per million of remaining funds not to exceed 1½% of the average teacher salary (\$705). Part time teachers will receive half this amount.

The District's contribution toward insurance will increase to \$334.18 which will continue to fully fund single Plan I for the employee.

#### Substitutes and Plan Time Compensation

The following language will replace section 21.4:

*As a last resort, when a substitute teacher or administrator is not available to cover a teacher's absence, other teachers may substitute during their planning time. When teachers substitute for at least one full planning period (approximately 45 minutes), they will be paid a stipend based on the hourly wage of the district's maximum teacher salary. Each building will establish a procedure which will provide an opportunity for all interested teachers to fairly share this coverage. No teacher will substitute during plan time more than once per week. Probationary teachers, teachers in the Awareness Phase of Track II, and teachers in Track III will not be eligible to cover classes.*

The Human Resources Department will assemble a committee of substitutes, administrators, and teachers to consider ways to improve substitute coverage. Data (to be determined by Professional Council) will be collected during the next school year and presented during next year's negotiations.

#### Middle School Planning Time

The first two sentences in section 21.2 will be replaced with the following:

*All middle school teachers shall have 50% of their daily scheduled plan time as an uninterrupted individual plan time (a minimum of 225 minutes per week). In the event there is an alteration to the regular school schedule, ie: testing, assembly schedule, etc. the principal in consultation with the teacher (s) will establish appropriate equitable schedules.*

#### Day Leave

The District and MVEA will educate staff about current day leave language in 9.1. The last two paragraphs in section 9.1 will be replaced with the following:

*MVEA and the District will jointly develop incentives to encourage judicious use of day leave. This item will be reviewed annually.*

For the 2008-2009 school year the following incentive program will be implemented:

*As an incentive, teachers who used fewer than five day leave days during 2007-2008 will be entered into a drawing for a chance to use their day leave on a day before or after a holiday during the 2008-2009 school year. Teachers who used four days will be entered once, those who used three days will be entered twice, two days will be entered three times, one day four times, and those who did not use any days will be entered into the drawing five times. In August 2008, one hundred fifty (150) different names will be drawn. Teachers whose names are drawn will be given a list of applicable dates and the number of slots available each day. Requests for specific days will be accepted on a first-come, first served basis. If a person requests a day whose slots are already filled, that person can select a different day that school year. Substitute coverage is guaranteed. Days used in this way cannot be taken consecutively with other day leave.*

#### Teacher Evaluation (New System)

The following language will be added to section 15.3:

*Sources of information for evaluating teachers in Track 2 may include any (multiple sources of) data relevant to a teacher's performance. Because teachers in Track 1, the Awareness Phase of Track 2, and Track 3 are scrutinized at a higher level, the evaluator should select data sources with increasing care. Therefore in such cases, the evaluator will directly observe the teacher in any professional setting to verify and document any concerns.*

#### TOSAs

New letter of agreement:

*The district and the association agree to the process of hiring and evaluating TOSA positions as set forth in the TOSA report dated April 2008 which will be on file at H.R. and MVEA offices.*

#### Reform and Meetings

The Reform Committee will consider the list of recommendations from negotiations with progress being reported to Professional Council. There will be an effort to inform and enforce current board policy defining the work day (GCL) and planning time agreements.

#### Other Items

Professional Council will consider ways to improve the transfer process and report back to pre-negotiations next year. ❖ Section 28.4 (Transitional 110-110 Retirement) is amended as follows:

*During the transitional year following P.E.R.A. retirement, the teacher shall remain in the same position, hours and at the same placement on the salary schedule, as prior to retirement subject to working the limit of 110 days/720 hours per calendar year. P.E.R.A. requires district contributions for 110 plan employees and the employee's pay will be adjusted to cover that cost.*

*The teacher shall not receive health care benefits or Day Leave (including sick leave) and cannot participate in the Sick Leave Bank. Teachers who participate in this plan may choose to postpone the retirement pay referred to in Section 28.1A.*

❖ A committee will consider possible adjustments in the student school day and report back to pre-negotiations next year. ❖ Budget for Professional Leave will be increased by \$35,000 to fund additional days and/or dollars. ❖ The co-curricular salary schedule will be updated to reflect the 3.5% salary increases and will be extended to 25 years. Coaches for CHAASA academic champion teams will receive \$250 stipend. Stipends page will be included in new addendum.

**Whereas:** The MVEA membership ratified the agreement on May 13, 2008;

**Therefore, be it resolved** the Mesa County Valley School District 51, Board of Education ratifies this agreement.
